A special provision is made for the taxation of incomes earned from business whether it is from profession, trade, occupation or business. This Act, in fact, differentiates between income earned from different sources, and taxation is levied at different rates in order to provide for equitable distribution of income tax burden. The Act seeks to tax only the income derived from the sources mentioned in the Act, that is, income is taxable only when earned. The act makes provision for the imposition of income tax and exemptions from it. It also provides a different rate of taxation on different incomes. It provides for exemption from income tax by a number of specified people, both individuals and HUF to enable them to avail certain exemptions. The Act imposes a special taxes such as personal, war and so on. It also imposes taxes on cigarettes and beverages; it makes certain other such provisions, like the duty on the sale of -Lahiri, etc. It also levies tax on interest on deposits
